

Cost of bid documents (Rs. 500/-) must be paid either by depositing in J&K Govt's treasury in MH 0055 or via bank transfer in the bank account of Chief Accounts Officer Relief Organisation (M) Jammu. Bank A/C No. 1246010200000023 Name of the Bank – **J&K Bank, Tirth Nagar, Talab Tillo, Jammu, IFSC Code: JAKA0TTALAB** Copy of the Treasury Remittance Challan/Bank acknowledgement slip (As the case may be), clearly mentioning the amount, transfer reference number, date and time of the transfer must be enclosed for getting the bid documents.
3. Bidders must submit the copies of acknowledgements of duly paid cost of bid document and earnest money for the bid in the required format along with the Bid documents.
4. Earnest money for the tender must be submitted in the form of **CDR or FDR** only, pledged in favour of Chief Accounts Officer, Relief Organisation (M) J&K Jammu.
5. Bids shall be received "on line" by or before 02:00 P.M., 06.01.2024. The bidder must possess Compatible Digital Signature Certificate (DSC) and proper user ID.
6. The hard copy of the tender documents shall be received only from the agencies who are qualified technically. EMD of the successful agency shall be retained by this Department till the successful completion of the contract period and the EMD of all the unsuccessful agencies shall be released back in their favor.
7. A Bidder requiring any clarification of the bidding documents may ask questions through email [relief-comm@jk.gov.in](mailto:relief-comm@jk.gov.in) by 05.01.2024 (by 3:00 PM) Any observation/suggestion/question shall not be considered after the scheduled date and Time.
8. Bids received on line shall be opened in the office of Relief & Rehabilitation Commissioner (M) J&K Jammu. If the office happens to be closed on the last date of opening of the bids as specified, the bids will be opened on the next working day at the same time and venue or any other date as fixed by the Relief Organization (M) J&K, Jammu.
9. The Relief Organisation (M) J&K Jammu reserves the right to cancel any or all bids without assigning any reason thereof.
10. The rates quoted shall be inclusive of all the applicable taxes.
11. All the applicable taxes shall be effective at the prevailing rates as fixed or notified by the Government from time to time and shall be deducted at source from the amount payable to bidder or firm/Agency as prescribed by the Government.
